## 2026 Spring Producer Program

- Only producers in good standing with Boehringer Ingelheim Animal Health (“Boehringer Ingelheim”) are eligible for this program.

- Only Qualifying Product purchased from **March 1 – April 30, 2026** (“Program Term”), will qualify. Redemptions must be submitted or postmarked by **May 31, 2026**, to qualify.
