PRODUCER

TERMS AND CONDITIONS

Only those products and product categories that are expressly stated in this 2026 One Merck Producer Program ("Program") and its supporting documents will be rebated. For a complete list of Merck Animal Health products, please request a catalog from a Sales Representative, Animal Health Supplier, visit MAHCattle.com, or call 800-521-5767.

ELIGIBILITY

This offer is open to cattle producers using Merck Animal Health products, except for those producers who are signed up on an upfront pricing agreement with Merck Animal Health. This Program is not intended for buying groups as single entities unless they are able to legally document common ownership to achieve tier status. Participants must understand that the products rebated on this offer are for exclusive use of the enrolled account and shall not be for wholesale or resale. Merck Animal Health reserves the right to: decline the enrollment of any participant, refuse the payment of any rebates or recalculate any previous or future payments, at its sole discretion. To qualify for payment, participants must comply with all terms within this rebate, and any other applicable terms related to this offer. Offer is void where prohibited by law. Merck Animal Health reserve the right to modify, expand, reduce, extend, or cancel this program upon 30 days written notice to participants in the program.

ENROLLMENT PROCESS

All participants in the 2025 Producer Program that achieved Tier 1 or higher with a minimum of \$15,000 qualified purchases are automatically enrolled in the 2026 Program. New enrollees, or accounts that did not participate in 2025 may join at any time by online submission by the Merck Animal Health sales rep only. Paper enrollments will not be accepted.

TIER LEVELS

Beginning January 1, 2026, participants will be paid on the tier and bucket achievement each quarter (see Rebate Calculation and Payments for true-up details).

Any combination of product purchases within a given bucket will count toward the achievement of that bucket. Participants with a SenseHub system achieve their bucket automatically.

Participants purchasing only ID products must achieve the dollar minimum noted in the grid based on tier enrollment to achieve the bucket. All ID product sales will count as volume builders for tier achievement. Rebates are paid on biopharma and vaccine sales only. No rebates are paid on ID products or SenseHub.

REBATE CALCULATION AND PAYMENTS

Rebate amounts will be calculated using quarterly tier and bucket achievement. Rebate checks will be mailed quarterly for all Program participants. Quarter 1 payments will be made based on the participant's initial placement in the Program grid. If a participant meets the minimum purchase requirements for additional buckets during a subsequent quarter, incremental rebate payments based on qualifying bucket purchases will be paid in the quarter following achievement. Rebates earned will accumulate until \$100 minimum check amount is reached. Rebates will be reconciled back to the beginning of the program and recalculated to achieved tier level at the end of the quarter, on a prorated basis. Allow six weeks for rebates to be processed.

PROOF OF PURCHASES

Merck Animal Health prefers EDI data as proof-of-purchase. Approved proof of purchase¹ is final and binding to participants.

Specific information will be required when submitting a manual invoice. Invoices must also be clear and legible. Missing/illegible information will result in a delay in processing. Information that is ultimately not provided will result in the submission not being processed and the rebate payment not made. The following information is required for each invoice submission:

- Dates of all product purchase (all must fall within the dates of the respective quarter), quantity (number of units) of product

ordered, price paid for each product, dollar purchase total, and participant name and number (SAP #). Invoices must be generated by the seller of the product(s).

- Invoices should be submitted monthly, where possible, but must be submitted no later than the end of the month following the end of the quarter.

- First quarter invoices (Jan - March) must be submitted no later than April 30.
- Second quarter invoices (April - June) must be submitted no later than July 31.
- Third quarter invoices (July - Sept) must be submitted not later than October 31.
- Fourth quarter invoices (Oct - Nov) must be submitted no later than December 31.
- All December 2026 invoices must be submitted no later than January 31, 2027.

- Participants who enroll in the Program after the start of the year will be allowed to submit manual invoices outside of the noted time frames. For example, if a customer enrolls in September, he/she will be eligible to submit manual invoices from the first two quarters without penalty. This applies only to new enrollments. From the time of enrollment forward, the participant must submit invoices by the noted deadlines.
