Program Details

2025 Fall Producer Program

- Only producers in good standing with Boehringer Ingelheim Animal Health (“Boehringer Ingelheim”) are eligible for this program.
- The Boehringer Ingelheim products shown on pages 1–3 of this flyer are included in the program (“Qualifying Products”).
- Only Qualifying Product purchases from **August 15 – October 15, 2025** (“Program Term”), will qualify. Redemptions must be submitted or postmarked by **November 17, 2025**, to qualify.
 - Rebates on Qualifying Products that are on backorder and ship during the Program Term will be awarded when the backorder is shipped and invoiced. Products that are on backorder and do not ship during the Program Term will not qualify for any rebate in this program.
- All redemption requests must include valid proof of purchase (invoice). Invoice(s) must clearly show:
 1. Qualifying Product names and the quantity of items purchased.
 2. Purchase dates for all Qualifying Products.
 3. Name of company where Qualifying Products were purchased.
 4. The price paid per Qualifying Product.
 5. Invoice total.
- Multiple web or mail submissions will be accepted, and multiple proofs of purchase can be used on each submission.
- One rebate will be calculated per submission, based on the listed Fall Producer rebate offers.
- Allow six to eight weeks for processing following submission.
- This promotional-incentive rebate is offered for sales in support of the Boehringer Ingelheim independently driven business plan.
- Boehringer Ingelheim reserves the right to end or modify the program, in whole or in part (including the removal or addition of Qualifying Products or product lines), at any time without notice.
- Producers enrolled in special Boehringer Ingelheim pricing programs are NOT eligible for this rebate offer.
- All sales must be INVOICED in the Program Term in order to be eligible for a rebate.
- All disputes must be received within 120 days of the program end and emailed to BIcattleEscalations@apfco.com. After this 120-day period, no further inquiries or claims will be honored, and the rebate will be considered final.
